***FAQs  
For the  
Annual General Meeting  
To be held on 28<sup>th</sup> August 2010***

**1. Who can vote in the AGM?**

Only the team captain of Sunday League, and Saturday League teams (mens'/womens') that played in the 2009/10 season can vote in the forthcoming AGM.

**2. If the captain cannot attend AGM in person?**

If any captain cannot attend the AGM in person or otherwise exercise his functions, a replacement representative may be nominated in writing by the members of his Team addressed to the Hon. Secretary to attend and otherwise exercise his functions, provided that such written nomination is submitted to the Secretary not less than **two (2)** days before **(i.e. by 2:30 pm, 26<sup>th</sup> August 2010)** the AGM is convened. In the event that a Team fails to submit such nomination on time or at all, the Team shall lose its voting right in the AGM.

**3. What positions are open for election at the AGM?**

Under the new constitution the following positions in the Executive Committee are open for nominations :

- President
- Chairman
- Hon Secretary
- Hon Treasurer

Nomination(s) can be made by any Life or Ordinary Member of the HKCA. All nomination form(s) must be returned to the HKCA office on or before **2:30pm, 17th August 2010.**

## ***HKCA Notice to Members***

Following the passing of the amendments to the Articles of Association in the last Extraordinary General Meeting held on the 16<sup>th</sup> July 2010, the forthcoming Annual General Meeting will be conducted under the new constitution.

The voting base for the HKCA shall now be via a team basis rather than an individual basis. In other words individuals will have their say at the team level and the captain of that team that participates in the Saturday or Sunday league or Womens league will cast a vote accordingly at the AGM. In addition to this, it has been recognized that a number of clubs have also developed in a more comprehensive way than others. That is, that both Little Sai Wan Cricket Association and Pakistan Association have a large membership basis, a significant number of active players and also have junior teams and development programmes. For this reason therefore both of these clubs be also represented as of right on the Executive Committee. There would remain an Independent Club's representative, as of now drawn from the remaining independent clubs.
